**ASSUMED NAME CERTIFICATE**

To register a Business Name in Brazoria County, the following is required:

1. You may check business names in the Brazoria County Clerk's Office in Angleton to make sure that someone else is not using the name you have chosen. These names are not protected which makes it important for you to check to make sure someone else has not already chosen this name. You may come into the County Clerks Office located at 1524 E. Mulberry in Angleton and search the name yourself at no charge or you may go to our web site at [www.brazoria.tx.us.landata.com](http://www.brazoria.tx.us.landata.com) under land records. For a fee of \$5.00, a search can be done for you at the Angleton Office or one of the substations listed below. You may not do a search at any of the sub-stations, as they do not have public computers available to you. After searching the name, you may pick up the form or print it from the web site. Our office can acknowledge your signature or you may take the form to a notary of your choice.
2. An Assumed Name filing is good for ten (10) years from the date of recording. The breakdown of the filing and copy fees are listed at the bottom of this letter. Money order, personal checks, company checks (made payable to Joyce Hudman County Clerk) or credit cards (MasterCard, Visa, American Express, & Discover – no debit cards accepted). Please check with your bank and determine if you need a plain or certified copy of the document.
3. Please note that the County Clerk's office does not perform name searches by telephone. All inquiries must be made either in person or by mail. A name search request by mail requires a \$5.00 fee for each name you request to be searched.

Filing Fees

\$16.00 for 1 page document w/one owner  
\$20.00 for 2 page document w/one owner  
\$ 0.50 for each additional owner

Copy Fees

\$6.00 for 1 page certified copy  
\$7.00 for 2 page certified copy  
\$1.00 for 1 page plain copy  
\$2.00 for 2 page plain copy
